Planning Board meetings are normally held on the **FIRST WEDNESDAY** (check with Secretary in case of Holiday) of each month at 7:30 PM in the Mullica Township Municipal Building, 4528 White Horse Pike, Elwood. One application must be submitted to the Board Secretary at least 30 days prior to the meeting date to deem the application complete and to be placed on the agenda. Once deemed complete, fifteen <u>collated</u> (15) copies must be submitted in full sets with any and all supporting documentation along with the appropriate filing and escrow fees. <u>If not submitted in sets, documentation will be returned to the applicant</u>. Fees for a Street Vacation (per street): \$100.00 Application; \$300.00 Escrow.

**NOTICE REQUIREMENTS**: A street vacation application requires notice. You must contact the Tax Assessor to receive a Certified List of Property Owners (cost \$10.00). Notices are to be sent by certified mail ten days prior to the meeting date. Also a notice must be placed in one of the Official Newspapers at least 10 days prior to the meeting. Certified list, green cards, copy of notice and proof of publication must be submitted to the Secretary prior to the night of the meeting.
